MINUTES AND MEETING NOTES

In accordance with the requirements of the United States Code of Federal Regulations, Title 21, Chapter 1, Subchapter A, Part 56, as well as Title 45, Part 46, the forty-fifth regular quarterly meeting of the American Naturopathic Research Institute (ANRI) and the Naturopathic Oncology Research Institute (NORI) and the International Naturopathic Clinical Research Institute (INCRI) and the Institutional Review Board (IRB) was called to order at 12:05 p.m., May 14, 2021 at 1250 E. Baseline Rd., Suite 205, meeting in Suite 203, Tempe, AZ 85283.

MEMBERS AND GUESTS

11 members and guests were in attendance, including 8 physicians and 3 non-physicians.

COVID-19 THERAPEUTICS

We discussed some of the commonly considered and less-frequently considered therapeutics.

COVID-19 VACCINE

Some of us in the meeting have observed people who have been in contact with covid-vaccinated people who themselves have had symptoms including: menorrhagia, metrorrhagia, post-menopausal bleeding, flu-like illness, clotting, 6 affected people in one clinic alone, quickly after close contact with recently vaccinated people.

Do we have therapeutics for 1ary, 2ary and 3ary exposure to the mRNA COVID vaccine?

Consider Vitamin A, because it's very therapeutic to the endothelium. Can we protect ourselves prophylactically with it?

Also, consider in the vaccinated: Vitamin D sufficiency, Zinc sufficiency.

Consider also homeopathic Thuja or Silica. Also consider treating the symptomatic patient with a nosode preparation of their own discharges. Also consider Gelsemium 3C.

Another idea 20 mule team Borax.

4-supercharged-C-60 is an antioxidant for mitochondria. Life expectancy of mice was increased by 14% when given this with olive oil.

The effect of the vaccine may attenuate with time. A patient in 40's had two Moderna shots. After a period of some months, there were no antibodies found to SARS-CoV-2. Another was PCR positive and sick with COVID. That person tested Ab = 5. Sicker individuals were seen to have antibodies closer to 20.

A naturopathic physician in Seattle advises against the COVID shot, due to its being experimental. The SCNM website urges students to get vaccinated, and offers \$500 for doing that. The State of Ohio enrolls its vaccinated residents in a lottery for \$1 million given away each Wednesday. Unvaccinated need not apply.

MASK & VACCINE LEGAL BATTLES

We discuss some legal considerations regarding masks and vaccines.

Sprouts changed their policy last week: Now you may or may not wear a mask.

As for vaccine passports, FL Gov DeSantis said it's illegal for businesses to require the vaccine, whereas AZ Gov Ducey took a laissez faire approach: businesses may choose to require vaccinations to enter, but the State of AZ will have no such requirement or "vaccine passport." Kelly Townsend introduced HB-2190 related to this.

COVID MISREPRESENTATION

The CDC has advised to run the PCR "test" of vaccinated people at 28 cycles, while unvaccinated people have typical cycle thresholds of 40. This has been calculated to lead to a $2^{12} = 4,096$ times greater chance for an unvaccinated person to "test" positive than a vaccinated person for covid. <https://www.cdc.gov/vaccines/covid-19/downloads/Information-for-laboratories-COVID-vaccine-breakthrough-case-investigation.pdf>

Also, the CDC has said that positive COVID results in vaccinated people should not even be counted, unless they are hospitalized.

10,000 doctors are participating in a lawsuit in Europe, prosecuted by Reiner Fuellmich, Esq., who is naming the CDC and WHO among other defendants for all kinds of covid-related malfeasance.

In the US, Robert F. Kennedy, Jr. and another attorney are suing regarding mandated covid vaccines. The Emergency Use Authorization is a status in which the covid vaccine cannot be required by employers or schools.

US economist Catherine Austin Fitts and Irish immunology Prof. Delores Cahill have a fascinating discussion at the link below about what might be called Pandemics, Incorporated. 8 pandemics since 2002 seem to have been dress rehearsals for the 2020 COVID extravaganza. They trace its history of patents, NIH/Fauci shenanigans, showing all the clues were there. Fitts attributes the need for pandemics partly to financial

adjustment needs in insurance and pension industries – killing off the old and sick, while collecting contributions, premiums from younger, less sick. They both have such interesting observations on the vaccine, gain-of-function viral bioweapons, even the relationship between a calcified pineal gland and fear, that the 2-hour talk goes rather quickly. <https://www.bitchute.com/video/fmuT1OOsxQaI/>

GRAND ROUNDS

Case 1: A 32 yo male had surgery for non-aggressive glioblastoma. It was resected completely. He had no chemotherapy or radiation. He had chosen instead to go to the Hoxsey Clinic for treatment, but then came to one of our doctors for treatment. She used a number of treatments. The patient has been feeling really great. At the 3-month follow-up, there was no tumor.

Case 2: One doctor works with ulcerative colitis and Crohn's patients. One had ten bloody bowel movements per day. The patient responded well to treatment.

Case 3: A child was seen with 4 fistulas. After treatment, the child had formed stools for the first time, and is still having normal stools.
