UPDATES OF RESEARCH FOR IRB REVIEW

There was a clarification of terms used in previously presented and approved research. The clarification was approved.

Mask vs No Mask the new England journal of medicine in may of 2020 they wrote a report that masks don't really work so therefore can or is almost used as a "talisman" where placed value on a specific item without scientific evidence.

The CDC in April of 2020 10 RTS randomized control study showed masks do not work. Reference graph on page 9 of 19. They are still in need of investors but have already received 2 quotes, one for \$700,000 and one for \$350,000. There are 2 potential investors (one from Saudi Arabia and one American.)
